OBJECTIVE :


This session had been organized to commemorate the INTERNATIONAL WOMEN'S DAY, observed all over the world. The declaration of this day by UNESCO was one of the steps for gender equality and equal opportunities for all. Keeping this in mind, we decided to remind our students and staff members, of their roles as responsible citizens of the country.

THE SESSION :

The Speaker explained the concept of the 'new woman' at the beginning of her presentation. The term 'new woman', she said, defines a woman who transcends all limits imposed upon her by society, declaring herself liberated from all possible constraints. Far from the media, or the radical feminist of literature, the New Woman was a single, professional woman who contributed to society by their work in the public sphere. The term came to be used in literature in 1894, first used by Sara Grand.

Speaking about the different waves of feminism and their impact on society, she highlighted the pros and cons of this movement which originated in Britain and the USA during the early part of the 19th century.

Today's women have advance far, from the days of yore, becoming multi-taskers. They are highly motivated, function well in both private and public domains, exercise rationality and logical thinking. Reminding us of Wollstonecraft's view that equality depends on capability

and effectivity in any individual, she stressed that women should not be discriminated against, when it comes to payment and opportunities.

But the 'modern woman' is not without any problems and obstacles. Since she is not just a wife or a mother, her tasks get multiplied, when she strives to put on a balancing act.

Moreover, in many cases, the bosses are neither supportive, nor co-operative. When the woman herself is the boss, many of her subordinates and colleagues find it difficult to accept her position, making her uncomfortable. The greatest challenge often comes from inside the family, demanding extraordinary service.

OUTCOME :

The students were provided practical guidance through this session and they felt free to raise issues and questions related to their families and social circles. Many of them realized the necessity of building their careers to become financially independent, so that they could fight against all odds. Other than firm resolve and desire, they learnt a few basic skills that would eventually make them confident and strong.

OBJECTIVE :

Women, it has been observed, form the backbone of every society. Hence, the development of women is the primary requisite, for the development of any society. The physical well-being of every woman is important no doubt, but one cannot ignore her mental health in any way. The exercise of the rational faculty, clarity of thought and expression, power to take decisions are fundamental to women's development today. Keeping this in mind, the Gender Sensitization Sub-Committee felt that our students should be given a fair idea of the various female-centric writings that highlight the role of women, their capabilities and strengths. The basic concept was to expose them to certain literary works which portray women as powerful, capable and intelligent women.

THE SESSION :

The session began with Dr.Chandrima Goswami Bhattacharya speaking on the role of women reflected in Sanskrit literature. She explained that in Sanskrit literature, epics, poems and drama show women in a positive role, individualistic and intelligent in their approach to the different facets of life, though in reality, the social picture was not of the same kind. She took the example of Kalidas' *Abhigyanashakuntalam* in which women characters appeal more strongly to a modern reader than his men characters. These women appear as symbols of compassion, generosity, persistence and patience. The female protagonist in the play is able to inspire the hero's aspirations with her own nobility and deep human affection. The second speaker Dr. Rizwana Nasira spoke about a few women writers who have upheld the concept of 'dignity of work', with reference to the diversity of work taken up by women. Referring to novelists Ashapoorna Debi, Mahashweta Debi, Nabaneeta Deb Sen and Suchitra Bhattacharya, Dr. Nasira pointed out that their characters are strong willed and focused. Braving the shackles of patriarchy, some of the characters emerge as 'modern women', deep-thinking individuals and exemplary in nature.

Prof. Sudakshina Sengupta talked about two seminal texts in English, presenting different backgrounds and periods of the women -characters. The texts under consideration were : Jane Austen's *Pride and Prejudice*, D.H. Lawrence's *Lady Chatterley's Lover* and Rassundari Debi's *My Life*. These texts, belonging to different periods and countries, have one thing in common : these texts portray women in a new light. The protagonists are bold, assertive and fighters in the true spirit. Ignoring aspersions, disregarding rumours and negative criticism, they stand as epitomes of courage and determination. Thus, they conquer all odds, inspiring the readers, providing them food for thought.

OUTCOME :

This session was meant to expose students to a variety of literary texts on women. At the end of it, our students got a fair idea of texts in Sanskrit, Bengali and English. They appeared engrossed in the stories, savouring all details with eagerness. Not only that, they developed a desire to read and feel. The feelings of independence, assertion and conviction were kindled in them, by the speakers.

OBJECTIVE :

In South 24 Parganas, West Bengal , women-trafficking is rampant and is a cause for concern even today. Dhruba Chand Halder College at Dakshin Barasat, South 24 Parganas, admit students from all sexes, backgrounds and localities. The hinterland from which the students hail, is extended and quite vast. Here, many families are extremely poor, often unable to make both ends meet. Women usually have to bear the brunt, as a result of which, they suffer. Since our students are young, unaware of the harsh reality around them, they have to be tutored and guided, so that they can differentiate between the good and the bad. Keeping this in mind, we organized a special session for them, for an acquaintance with reality.

THE SESSION :

This session was conducted in three phases: the first by Sri Atanu -----, the second, by Ms. Babita and the third by a trafficked woman who had been rescued by the International Justice Mission. The I.C narrated the different ordeals suffered by mostly young women, because of their ignorance and innocence. He talked about cyber crime and how it affects the lives of young

girls. He advised our students to exercise caution while accepting an unknown person as a friend, and to contact the local police station if they found anything suspicious.

Ms. Babita, a field officer with I.J.M, spoke about her organization, which is focused on human rights, law and law enforcement. She explained that her organization was committed to the protection of people living in poverty; rescuing victims of violence and bringing criminals to justice. She pointed out the different circumstances and situations which often lead to human trafficking. Young girls living in poverty are the easiest preys. Moreover, young girls are mostly allured when they are promised heavy salaries or expensive gifts. She cautioned the students, advising them not to step into any trap set for them.

A young lady who had fallen victim to the traffickers, but was eventually rescued, spoke to the students about her own ordeal and the sufferings she had to go through. She also cautioned our girl students against the various allurements spread out for them.

THE OUTCOME :

Our students were exposed to a new world where there are uncertainty and suffering. They understood the temptations which often lead to insecurity and alienation. They also realized that it is very difficult for such victims to get accepted by the society. At the end, our students understood the need for self-security and safety.




