Sub: Policy on Daily Allowances, Travel Eligibility, Communication Reimbursement, Reimbursement for Mobile Bills / E - Reporting / E - Detailing / Cyber Cafe, Hill Station Allowance, Transit Allowance, Meeting Allowance & Vehicle Allowance.

#### **OBJECTIVE**

The purpose of this policy is to frame the entitlements for Trainee / Probationary Sales Executives in respect of Travel Eligibility, Various allowances and reimbursements as specified below.

This policy comes into effect from 1st October, 2018 and supersedes all policies and practices existing as on date. The same shall remain operative until amended / modified.

The intention of the policy is to reimburse entitled fare and just allowances / expenses admissible while under taking official work and should be interpreted as such.

#### DAILY ALLOWANCES:

Rs. 50/- per day on actual working day only employee at Ahmedabad / Bangalore / Chennai / Delhi / Hyderabad / Kolkata Head Quarter shall be eligible to claim Rs. 235/- + Rs. 50/- = Rs. 285/- per day for HQ working.

- 6. Fare is payable on per Kilometer basis and hence, the shortest route between two places will be taken as approved distance for reimbursement.
- 7. For distance beyond 900 Kms. (One Way) III Tier A.C. / A.C.Chair Car Rail fare or Actual Bus fare shall be reimbursable on the basis of actual tickets.
  - However travel by III Tier A.C. / A.C. Chair Car / Bus for distance beyond 300 Kms (One Way) shall be permissible and the Actual Rail / Bus Fare shall be reimbursed on the basis of actual tickets.
- 8. In case of non-availability of reservation in entitled class or non- availability of such class on specific route, journey shall be made in class below the entitled class.
- 9. All routes / modes of travel shall be as per approved STP / SFC.

#### G. COMMUNICATION REIMBURSEMENT:

- 1. This reimbursement is payable towards expenses like Speed post, Courier, Fax, Stationery items, Xerox, Print-Out, Scan etc. and is strictly of reimbursement in nature and shall be reimbursed upto a maximum of Rs. 250/- per month.
- H. REIMBURSEMENT OF EXPENSE FOR MOBILE BILLS (VOICE AND DATA) / E-REPORTING / E-DETAILING / CYBER CAFE:

Cyber Cafe Expenses for Official work / Mobile bills shall be reimbursed as per the details below:

- i. Employee shall be entitled to reimbursement upto Rs. 399/- (excluding taxes) for Reimbursement of Mobile Bills (Voice and Data) / E-Reporting / E-Detailing.
- ii. Further, employee shall be eligible for reimbursement upto maximum of Rs. 200/- per month for Cyber Cafe expenses or Internet charges for home Computer.
- I. HILL STATION ALLOWANCE: Rs. 50/- per day on actual full working day.
- 1. Out / Ex-station working at following places is permissible for additional hill station allowance.
- 2. Hill station allowance is an additional allowance to facilitate working at Hill Stations.


